**AUDIT COMMITTEE**  
**TERMS OF REFERENCE**

---

*Constitution*

1. The board of directors (the “**Board**”) of Kate China Holdings Limited (the “**Company**”) which together with its subsidiaries, the “**Group**”) has resolved to establish a committee of the Board to be known as the Audit Committee (the “**Committee**”) at a meeting held on 30 June 2014.

*Membership and Quorum*

2. All members of the Committee (“**Members**”) shall be appointed by the Board from amongst the non-executive directors of the Company and shall consist of not less than three members, a majority of whom shall be independent non-executive directors of the Company and at least one of whom has appropriate professional qualifications or accounting or related financial management expertise as required under the Rules Governing the Listing of the Securities on the Growth Enterprise Market of The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”). A quorum shall be two members, in particular but not limited to Rule 5.05(2) of the Listing Rules or any succeeding provisions thereof. If a Member ceases to assume the responsibilities of a director of the Company (the “**Director**”), that member shall automatically lose the qualifications as a Member and the Board shall appoint a new Member to complement the number of Members in the Committee.
3. The appointment of the Members may be revoked, or additional members may be appointed to the Committee by separate resolutions passed by the Board and by the Committee.
4. The chairman of the Committee shall be appointed by the Board and must be an independent non-executive director of the Company.

5. A former partner of the Group's existing auditing firm shall be prohibited from acting as a member of the Committee for a period of one year from the date of his/ her ceasing:
  - (a) to be a partner of the firm; or
  - (b) to have any financial interest in the firm, whichever is later.

#### ***Responsibilities***

6. The Committee is to serve as a focal point for communication between other directors, the external auditor and the internal auditor as regards their duties relating to financial and other reporting, internal controls, external and internal audits and such other matters as the Board determines from time to time.
7. The Committee is to assist the Board in fulfilling its responsibilities by providing an independent review and supervision of financial reporting, by satisfying themselves as to the effectiveness of the internal controls of the Group, and as to the adequacy of the external and internal audits.

#### ***Notice***

8. A meeting of the Committee may be convened by any Member or by the Secretary.
9. Unless otherwise agreed, notice of each meeting including the venue, time and date, together with an agenda of items to be discussed, shall be issued to each member of the Committee and any other person required to attend no fewer than 3 working days prior to the date of the meeting. Notice of any adjourned meetings is not required if the adjournment is for less than 14 days.

#### ***Attendance at meetings***

10. The Chief Financial Officer, the head or a representative of the Internal Audit Department, and a representative of the external auditor shall normally attend meetings. Other Board members shall have the right to attend meetings of the Committee. However, the Committee shall meet with the external auditor of the Company without the presence of its Executive Directors at least once a year.
11. Only the Members are entitled to vote at the meetings.

### *Authority and Duties*

12. The authority of the Committee is derived from the Board, therefore the Committee is obliged to report to the Board on its decisions or recommendations, unless there are legal or regulatory restrictions on its ability to do so.
13. The Committee is authorised by the Board to perform its duties within the scope of these terms of reference and the Group shall provide the Committee with sufficient resources to perform its duties. It is authorised to seek any information it requires from any employee of the Group and members of the Board in order to perform its duties and all employees of the Group and members of the Board are directed to co-operate with any request made by the Committee within the scope of these terms of reference.
14. The Committee has the authority to exercise the following powers:
  - (a) to monitor whether the Group's management has, in the performance of its duties, infringed any policies set by the Board or any applicable law, regulation and code (including the Listing Rules and other rules and regulations from time to time laid down by the Board or a committee thereof) and report to the Board should such infringement are of sufficient importance to warrant the attention of the Board;
  - (b) to investigate any activity within these terms of reference and all suspected fraudulent acts involving the Group and report to the Board should such infringement are of sufficient importance to warrant the attention of the Board and request the management of the Group to make investigation and submit reports;
  - (c) to review the Group's internal control procedures and system;
  - (d) to review the performance of the Group's employees in the accounting and internal audit department;
  - (e) to make recommendations to the Board for the improvement of the Group's internal control procedures and system;
  - (f) to request the Board to convene directors or shareholders' meeting for the purposes of revoking the appointment of any director and to dismiss any

employee if there is evidence showing that the relevant director and/or employee has failed to discharge his/her duties properly; and

- (g) to request the Board to take all necessary actions, including convening an extraordinary general meeting, to replace and dismiss the auditors of the Group.

15. The Committee shall have the following duties:

Relationship with the Group's auditors

- (a) to be primarily responsible for making recommendations to the Board on the appointment, reappointment and removal of the external auditor, and to approve and (periodically) review the remuneration and terms of engagement of the external auditor and any questions arising from its resignation or dismissal;
- (b) to review and monitor the independence and objectivity of the external auditor and the effectiveness of the audit process and reporting obligation in accordance with applicable standards. The Committee shall:
  - i. consider the relationship between the Group and/or the directors of the Company and the external auditors;
  - ii. obtain from the external auditor annually, information about policies and processes for maintaining independence and monitoring compliance with relevant requirements, including those for rotation of audit partners and staff; and
  - iii. meet with the external auditor, at least annually in the absence of the management of the Group, to discuss matters relating to the audit fees, any issues arising from the audit and any other matters the external auditors or the Committee may wish to raise;
- (c) to develop and implement policy on engaging an external auditor to supply non-audit services. If a compelling reason exists to engage the external auditor due to their unique expertise in a particular area, prior approval of the Committee is required. For this purpose, "external auditor" includes any entity

that is under common control, ownership or management with the audit firm or any entity that a reasonable and informed third party knowing all relevant information would reasonably conclude to be part of the audit firm nationally or internationally. The Committee should report to the Board, identifying and making recommendations on any matters where action or improvement is needed;

- (d) to evaluate the cooperation received by the external auditors, including their access to all requested records, data and information; obtain the comments of management regarding the responsiveness of the external auditor to the Group's needs; inquire the external auditor as to whether there have been any disagreements with management which if not satisfactorily resolved would result in the issue of a qualified report on the Group's financial statements;
- (e) to discuss problems and reservations arising from the quarterly (if any), interim and final audits, and any matters the external auditors may wish to discuss (in the absence of the Board and other employees of the Group at the discretion of the Committee where necessary);

#### Review of financial information of the Group

- (f) to monitor the integrity of financial statements and the annual report and accounts, half-year report and quarterly reports, and to review significant financial reporting judgments contained in them. In reviewing the Group's reports and accounts before submission to the Board, the Committee shall focus particularly on:
  - (i) any changes in accounting policies and practices;
  - (ii) major judgmental areas;
  - (iii) significant adjustments resulting from the audit;
  - (iv) the going concern assumptions and any qualifications;
  - (v) compliance with accounting standards;
  - (vi) compliance with the Listing Rules and legal requirements in relation to financial reporting;
  - (vii) whether all relevant items have been adequately disclosed in the Group's financial statements and whether the disclosures give a fair view of the Group's financial conditions;
  - (viii) the fairness and reasonableness of any connected transactions and their

impact on the profitability of the Group and whether such connected transactions, if any, have been carried out in accordance with the terms of the agreement governing such transactions;

- (ix) items requiring disclosure; and
  - (x) the cash flow position;
- (g) in respect of (f) above, the Members shall liaise with the Board and the senior management of the Group;
- (h) in respect of (f) above, the Committee should consider any significant or unusual items that are, or may need to be, reflected in the reports and accounts, it should give due consideration to any matters that have been raised by the Group's staff responsible for the accounting and financial reporting function, compliance officer or auditors;
- (i) to review the draft representation letter prior to approval by the Board;

#### Oversight of the Group's financial reporting system and internal control procedures

- (j) to review with the Group's management, external auditor and internal auditor, the Group's financial controls, internal control and risk management systems as well as any statement by the directors to be included in the annual accounts prior to endorsement by the Board;
- (k) to discuss the internal control system with management of the Group to ensure that the management of the Group has performed its duty to have an effective internal control system. This discussion should include the adequacy of resources, staff qualifications and experience, training programmes and budget of the Group's accounting and financial reporting function and to monitor the rectification of any weaknesses that may be revealed from time to time;
- (l) to consider major investigation findings on internal control matters as delegated by the Board or on the Committee's own initiative and the Group's management's response to these findings;
- (m) where an internal audit function exists, to ensure co-ordination between the internal and external auditors, and to ensure that the internal audit function is adequately resourced and has appropriate standing within the Group, and to review and monitor its effectiveness;

- (n) if deemed necessary by the Committee, to appoint an external auditor or professional firm to review the internal business procedures and internal control matters of the Group;
- (o) to review and familiarise with the Group's financial and accounting policies and practices applied by the Group in preparing its financial statements;
- (p) to review the external auditor's management letter, any material queries raised by the auditor to the management of the Group about accounting records, financial accounts or systems of control and management response;
- (q) to ensure the Board will provide a timely response to issues raised in the external auditors' management letter;
- (r) to implement any remedial plans recommended by the internal control department of the Group should there be any internal control deficiencies;
- (s) to prepare work reports for presentation to the Board and to prepare summary of work reports for inclusion in the Group's interim and annual reports;
- (t) to report to the Board on the matters set out above;
- (u) to consider other matters, as defined or assigned by the Board from time to time;
- (v) to fulfill any other responsibilities as required by the Listing Rules from time to time;

#### Corporate Governance Functions

- (w) to develop and review the Group's policies and practices on corporate governance and make recommendations to the Board;
- (x) to review the Group's compliance with the Corporate Governance Code and disclosure in the Corporate Governance Report in Appendix 15 of the Listing Rules;

### Other Duties

- (y) to review arrangements which employees of the Group can use, in confidence, to raise concerns about possible improprieties in financial reporting, internal control or other matters. The Committee should ensure that proper arrangements are in place for fair and independent investigation of these matters and for appropriate follow-up action;
- (z) to act as the key representative body for overseeing the Group's relations with the external auditor;
- (aa) to report to the Board on the matters set out in the Corporate Governance Code and Corporate Governance Report in Appendix 15 of the Listing Rules;
- (bb) to consider other topics and review other documents as may be reasonably requested by the Board from time to time;
- (cc) to apprise the Board of significant developments in the course of performing the above duties; and
- (dd) to review the findings of internal investigations and management's response into any suspected frauds or irregularities or failures of internal controls or infringements of laws, rules and regulations.

### *Consultation*

16. The Committee shall, at the expenses of the Group, have access to professional advice if considered necessary and be authorised to request their attendance in the Committee's meetings where necessary.

### *Secretary*

17. The secretary of the Company (or his/her delegate) shall be the secretary of the Committee (the "**Secretary**").

### *Meetings*

18. The Committee shall meet as and when necessary or as requested by any Committee member.

19. The Committee shall meet not less than four times a year to consider the budget, revised budget and yearly, half yearly and quarterly report prepared by the Board. However, at least once a year the Committee shall meet with the external auditors in the absence of any executive director of the Company and other staff member of the Group unless otherwise requested by the Committee.
20. The chief financial officer/financial controller, the head of internal audit of the Company and a representative of the external auditors shall normally attend meetings of the Committee.
21. Relevant notice, including an agenda and accompanying papers, shall be sent in full to all Members in a timely manner and at least 7 days before the intended date of the meeting of the Committee (or such other period as agreed by its members).
22. The meetings and proceedings of the Committee should follow the provisions of the Articles of Association of the Company for regulating the meetings and proceedings of the Board so far as the same are applicable and are not replaced by the provisions in these terms of reference.
23. In the case of an equality of votes at a meeting of the Committee, the chairman of the meeting shall have the casting vote.

***Disagreement as to appointment of external auditors***

24. In the event the Board disagrees with the Committee's view on the selection, appointment, resignation or dismissal of the external auditors, the Committee shall provide a statement explaining its recommendations to the Group and the reasons why the Board has taken a different view for inclusion in the Corporate Governance Report issued by the Group in accordance with Appendix 15 of the Listing Rules.

***Reporting Procedures***

25. Full minutes of the meetings of the Committee and all written resolutions of the Committee should be kept by the Secretary.

26. The Secretary shall circulate the draft and final versions of minutes of the meeting of the Committee or, as the case may be, written resolutions of the Committee to all Members for their comment and records respectively within a reasonable time after the meeting or the passing of the written resolutions.
27. The Secretary shall keep full minutes of each Committee's meeting. Draft and final versions of minutes of the meetings shall be sent to all Committee members for their comments and records within a reasonable time after such meeting.
28. The Committee should report to the Board on a regular basis. At the next meeting of the Board following a meeting of the Committee, the chairman of the Committee shall report to the Board on the findings and recommendations of the Committee.
29. Directors and Members shall be entitled to have access to these committee papers and related materials. These committee papers and related materials should be in a form and quality sufficient to enable the Committee to make informed decisions on matters placed before it. Queries raised by Members should receive a prompt and full response, if possible.
